## OBSERVER CORP

Concerned about the environmental effects of new development in our rural areas? Have you seen South County lately? The Observer Corps needs you!

The Thurston County Planning Commission will be holding public hearings on changes to the Critical Areas Ordinance, currently scheduled for April 2 and April 16. They are working on a draft ordinance now. The CAO is the primary regulation in Thurston County for limiting development in sensitive areas like wetlands, steep slopes, endan-

gered species habitat, etc. We need members to follow this process by attending meetings and helping us stay up-to-speed.

The Planning Commission meets 1<sup>st</sup> and 3<sup>rd</sup> Wednesdays at 7:00 p.m. at the County Courthouse. We can contribute to how this regulation comes out. We also need volunteers to help with changes to the Comprehensive Plan and Development Regulations that are being proposed for this year. One long-running proposal would change the rules for Designated

Mineral Lands (code for gravel pits and asphalt plants), which were popping up around our rural areas with shocking frequency not long ago. A public hearing is scheduled for February 24 at 3:15 p.m. before the Board of Commissioners.

## COOL THURSTON CAMPAIGN

Have you been hungering to make changes and be part of the solution to climate change, but unsure how?

Join others on March 2<sup>nd</sup> at a Global Warming Café workshop to launch the Cool Thurston Campaign.

This Campaign is a strategy to make big changes in the global environment by starting at the individual level. It is centered on the book "Low Carbon Diet, A 30-Day Pro-

gram to Lose 5000 Pounds" by David Gershon.

At the Global Warming Café you will learn how to take action on climate change, and form or join an Eco-team. Eco-teams can be anything from one individual or household, to a neighborhood, social group, workplace, or other group of 8-10 members. The teams help each other take actions that lower their household (or business) contribution

to the greenhouse gasses responsible for climate change. Your team meets four times, and ultimately you each lose 5000 pounds of your yearly greenhouse gas emissions.

## BOTTLEMANIA, by Elizabeth Royte

When Europeans first arrived in North America, growing things, wild life, land, air and water were all free for the people to use as needed. Today air, although heavily polluted in some areas, is free. The other gifts of nature are increasingly commodities.

Bottlemania: how water went on sale and why we buy it, by Elizabeth Royte is a lively account of the process of commercialization. With personal accounts of bubbling springs, contentious town meetings and examinations of human health, Royte keeps the reader alert.

For example, it takes a thousand tons of water to grow one ton of grain. I didn't know that. Clearing

land, cutting trees and paving surfaces, building more roads, all allow erosion and speed the flow of sediment into creeks. I did know that.

Some of the stories Royte tells of constant battles, especially against Nestle are depressing. Big international corporations are not easily discouraged. It's not over until its paved over, is a truism known to many in Thurston County.

An amount of oil equal to the contents of a plastic bottle is required for its manufacture. So in buying bottled water, not only is the environment harmed from the collecting and bottling of the water, but the carbon emissions are increased by the manufacture of the

container.

All is not gloom and doom however. The book contains ways we can reclaim this natural resource for free public consumption. First, of course, is to kick the bottle water habit.

Royte details the circumstance in which bottled water is appropriate: in an emergency when fresh clean tap water is unavailable. The more people relish water in bottles the less they seem to care about pure tap water.

Keeping municipal water supplies drinkable is the first line of defense against privatization of a public resource.
